I have been recently reading *The* Freemasons, A History of the Worlds Most Powerful Secret Society and I pass along this paragraph for your enjoyment.

In 1920, as result of a campaign waged by influential groups, a constitutional amendment was created that prohibited the drinking of alcohol throughout the United States. This would have not suited the English Freemasons when it was said that one of their secrets was the name of the brother who succeeded in drinking the other brothers under the table at their last lodge dinner. But the English drink to the Queen's health and other toasts at dinner in champagne and other wines. The Freemasons in the U.S. happily accepted Prohibition as several lodges had already given up alcohol and joined the campaign that led to the imposition of Prohibition.

Now, most U.S. lodges drink toasts in wine either during or after dinner. There are regular toasts to country, followed by a pledge of loyalty to the flag, to the president, to their Grand Lodge, to the brothers serving in the armed forces, and to departed brothers.

Now. I was told by my coach and mentor Illustrious Worshipful Morris White that three things were banned from the lodge...politics, religion, and alcohol. I guess the author never traveled to this neck of the woods, or I have not visited enough lodges.

Fall is upon us and so is the Grand Annual Communication. The first week in November is the time appointed for this event. Our officers and members are finalizing plans to attend this grand session. In doing so

there are 2 important matters that will be

presented, discussed, and acted on while Grand Lodge is in session. I would like to share these 2 resolutions for your attention so that we may discuss them and provide our feedback to Worshipful Bill Rawson so he may cast his ballot according to our desires.

The first resolution deals with Section 2.135 of the Methodical Digest. A visitor, other than a Grand Officer, or District Deputy Grand Master cannot enter, or remain in any Lodge if any member objects. The intent is to change the wording of this section to clarify the circumstances when it is appropriate to object to sitting in Lodge with a visiting Brother and to provide the necessary discretion to the Worshipful Master.

The second resolution relates to Section 2.19 of the Methodical Digest. Dues of subordinate lodges. This resolution is presented to request an increase in the Grand Lodge assessments to every charterer Lodge. The current assessment is \$28 dollars per member and the increase requested would require every Lodge to remit \$38 dollars per member. The reason for this request has to do in large part with inflation and a decline in income. The Grand Lodge predicts that if there are no increases and the current level is maintained there will be a budget deficit by 2012.

The latter resolution failed last year, in large part due to failure to properly notify the members of this needed action. This is not the case for this year. We, the officers of Kempsville Lodge have discussed this in prior Ashlar articles and have encouraged LIMP for those who are able to invest in our lodge. These resolutions, as drafted, will be read at our next stated communication.

I would like to thank Brother Bill Peterson for making the necessary arrangements for us to attend Grand Annual Communication.

Please consider attending the October Stated for Iunior Warden's Night.
